(note from me):

I headed my letter "my old blue van in a car park in Romford" in my efforts to get the Police to realize that I was no longer able to live in my house in College Street, Ammanford.

A house that was free from mortgage and was intended for our retirement

NOTED MENTAL HEALTH TEAM

I HAVE REPORTED MATTERS TO DYFED POWYS POLICE AND THEY HAVE NOT BEEN INVESTIGATED PROPERLY.

I HAVE POSTED DETAILS AND RECORDINGS ON TO THE INTERNET AND MADE A PETITION ON CHANGE.ORG

I CONSIDER THAT ATTEMPTS WERE MADE TO MURDER MYSELF AND MY WIFE DURING JULY 2018 AND AUGUST 2018.

THIS WOULD HAVE BEEN EASILY PROVABLE AT THE TIME.

IN MAY 2019 I RETURNED TO MY HOUSE AND COLLECTED 4 BATH TOWELS, I PLACED THEM IN MY VAN, FUMES CAME OFF THESE TOWELS AND IT WAS NOT LONG BEFORE MYSELF AND MY WIFE HAD STREAMING EYES, SORE THROATS, RUNNING NOSES AND STARTED GETTING CONFUSED JUST LIKE WE DID WHEN WE WERE GASSED

THE RESIDUE IS CLEARLY STILL AT THE PROPERTY AND COULD BE TESTED

I BELIEVE I UNCOVERED A SERIOUS CRIME GANG OPERATING FROM SOMEWHERE UNDERNEATH THE FLOOR OF MY BASEMENT

I HAVE MANY RECORDING MADE IN THIS AREA THAT DYFED POWYS HAVE REFUSED TO LISTEN TO

ON THOSE RECORDINGS AUTOMATED MACHINES CAN BE HEARD RUNNING AROUND THE CLOCK

WOMEN AND CHILDREN CAN BE HEARD SCREAMING

I BELIEVE THAT THESE PEOPLE ARE HELD AS SLAVES AND ABUSED ON A REGULAR BASIS

I ALSO BELIEVE THAT CERTAIN DYFED POWYS POLICE OFFICERS HAVE COLLUDED WITH EACH OTHER AND PERSONS UNKNOWN TO PROTECT THIS CRIMINAL GANG

I'VE SPOKEN TO CHRISTINE TAIT WHO IS ADAMANT THERE ARE NOISES COMING FROM BELOW THE BASEMENT IN THEIR BUILDING.

SHE ACTUALLY CLAIMS THERE ARE TUNNELS UNDER THEIR BASEMENT AND THEY BELIEVE PERSONS ARE BEING TRAFFICKED OR EVEN KILLED.

I ALSO ASKED MRS TAIT WHERE THEY CURRENTLY WERE AND
SHE DECLINED TO TELL ME STATING THEY DIDN'T TRUST POLICE
OFFICERS FROM DYFED-POWYS POLICE

(note from me):

*What we actually said is that we did not trust certain police officers from
Dyfed-Powys Police.*

*I think our comment was justified especially after we proved that one of the
Police documents had been faked and that one of the police reports that said I
had been seen by the Mental Health crisis team was untrue.*

I'VE RECEIVED SEVERAL E-MAILS FROM MR TAIT MOST OF THEM ONLY CONTAINING ONLINE SITES I CAN VISIT TO SEE THE SUPPORT THEIR CAMPAIGN IS GATHERING.

(note from me):

I sent him a link to our petition so he could see the number of people that had backed our petition and the comments that they had made after listening to the noises that we had recorded.

Many other people thought that the noises were suspicious and needed investigating.

THERE IS ONE E-MAIL CONTAINING A LINK WHICH HE CLAIMS IS A RECORDING OF SOME PERSON SAYING 'THE BABY HAS DIED'

I'VE ALSO HAD AN E-MAIL WITH A LINK TO A WALES ONLINE ARTICLE POSTED TODAY IN RELATION TO THE ALLEGATIONS OF MR TAIT

WITH THE ASSISTANCE OF DCCU I'VE LISTENED TO THE RECORDING SENT TO ME BY MR TAIT AND YOU CAN HEAR WHAT SOUNDS LIKE A CHILD SAYING "THE BABY DIED" BUT THEN YOU CAN HEAR WHAT SOUNDS LIKE BIRDS TWEETING WHICH WOULD SEEM STRANGE IN AN UNDERGROUND TUNNEL.

Note by me:

There are three words that are very clear before the words "the baby died" as can be heard here

In my opinion the voice is not that of a child but of a woman in distress.

I'VE LISTENED TO ALL THE RECORDINGS AND CANNOT FIND ANY EVIDENCE OF ANY OFFENCES.

THIS WAS INITIALLY REPORTED TO POLICE IN 2018 AND INVESTIGATED WITH NFA.

MR TAIT MADE A COMPLAINT TO PSD AND NFA WAS TAKEN.

MR TAIT WAS INFORMED THAT THE NOISES APPEAR TO BE GENERAL BACKGROUND NOISES WHICH WOULD BE EXPECTED TO BE HEARD WITHIN THE TOWN CENTER NEAR THE ADDRESS AND THAT NONE OF THE NOISES CAUSED ANY IMMEDIATE CONCERN.

THIS STORM MESSAGE WAS CREATED AS MR TAIT HAS SENT A LETTER ON 17/06/19 TO PSD ASKING THE INVESTIGATION IS INVESTIGATED AND DURING E-MAILS HAS MENTIONED A BABY BEING KILLED

THEREFORE THIS LOG WAS CREATED.

MR TAIT WAS REFERRING TO THE RECORDING MENTIONED ABOVE WHICH HAS BEEN LISTENED TO AND AS STATED DOES SOUND LIKE A CHILD SAYING "THE BABY HAS DIED"

HOWEVER THERE IS NO EVIDENCE TO SUPPORT THAT THESE ARE GENUINE AND NOT TAKEN OUTSIDE NEAR A BUSY ROAD OR EVEN TAKEN OFF THE TELEVISION OR INTERNET.

(note from me):

This officers version of events is not consistent.

Firstly he says he can hear birds in the recording, then that the recording could have been taken outside by a busy road, but if that was the case, would you not expect to hear traffic?

Opposite the house there is a bus station, a loud bleeper can be heard every time a bus leaves the station.

The officer then states that we might have taken the recording from the TV or the Internet, but for that to be plausible a recording of a lady in distress saying "Why Gareth, why? The Babies died" followed by the sounds of birds would have to exist on the TV or radio.

Given the seriousness of the content of the recording I would have expected the police to have spoken with the two ladies who recorded the sound.

I do not know what the crosses refer to but in this case they appear to be redaction.

The bit where it is stated we live in a caravan is incorrect, we lived in the back of an ordinary van.

Who is the officer reporting to?

He seems to be keeping someone outside the Police force up to date with developments and intends to "add endorsements" to an already published news article.

The news articles that had already been published were removed from the internet.

The only ones that were left up were articles that stated the noises were of ghosts and the like, this can be seen on this webpage:

There were many recordings available, the officer chose to focus on just one of them.

A recording that was not made by me but someone else, that someone else was not questioned about the recording.

ADVICE IS TO UPDATE MR TAIT IF HE IS NOT HAPPY WITH MY DECISION TO COMPLAIN THROUGH THE CORRECT CHANNELS.

I'VE SPOKEN TO MRS TAIT TO EXPLAIN THAT THERE IS NO NEW EVIDENCE HERE FOR ME TO AUTHORIZE A FURTHER INVESTIGATION EXPLAINING THAT THE INITIAL COMPLAINT IN 2018 WAS THOROUGHLY INVESTIGATED BY AMMANFORD OFFICERS AND THERE WAS NO EVIDENCE TO SUPPORT THE CALLERS ALLEGATIONS AT THAT TIME

(note by me):

The Police had our allegations of serious crime, perhaps coming from the house next door, they phoned the owners of the house next door and asked for an appointment to look inside.

An appointment was made and the officer was eventually allowed in to the house a full 16 weeks after I first made my allegations.
